RANK-AND-FILE COMMITTEE TO BE SELECTED MONDAY FOR M.E.B.A. ELECTION COUNT

If you're near one of the six Union halls holding a Special Membership Meeting on Monday (Nov. 25), stop by to help elect five members and one alternate to form a six-person Rank-and-File Election Tallying Committee. Union halls hosting Nov. 25 Special Meetings will be held at halls in *New York/New Jersey*, *Tampa*, *Houston*, *Norfolk*, *Seattle* and *San Francisco (Oakland)*. The elected Oakland member will serve as the Alternate on the Committee if all six members attend. The Committee will help oversee the tabulation of District election ballots on December 2nd.

The Houston hall will have their meeting at their new location - 6604 South Loop East. The Tampa Union hall will hold their meeting at Coppertail Brewing Company (2601 E 2nd Ave in Tampa).

Each of the six halls will hold their Special Meetings following job call, but make sure you contact that particular hall to confirm in advance because times could vary. A quorum for a special membership meeting is five or more members. The election of a Tallying Committee member will be the only item on the agenda at these Special Meetings. Please urge members to attend and participate in the Nov. 25th Special Meetings.

DUFFY APPOINTED TO HEAD DOT

President-elect Donald Trump announced many of his leadership picks for his second administration including the selection of Sean Duffy as the next Secretary of Transportation. The 53-year old Duffy represented Wisconsin's 7th District in Congress from 2011 to 2019. He is a former prosecutor and television personality who co-hosts a business segment on *Fox News*. He served on financial and oversight committees during his Congressional career but was relatively inactive on maritime issues. The industry is optimistic that he will understand the importance of the U.S.-flag fleet to our national and economic security and we look forward to collaborating with him on those issues once confirmed.

Rep. Mike Waltz (R-FL) was tapped to serve as Trump's national security advisor, the top security policy role in the White House. A former Green Beret, Waltz previously worked as a defense policy

director under Secretaries of Defense Donald Rumsfeld and Robert Gates. Elected to represent Florida's 6th District in 2019, Waltz currently sits on the House Armed Services Committee. He has been a vocal advocate on behalf of U.S.-flag shipping and, along with Senators Mark Kelly (D-AZ) and Marco Rubio (R-FL) as well as Rep. John Garamendi (D-CA), co-authored the "Congressional Guidance for a National Maritime Strategy," legislation to return the U.S. to shipping prominence while bolstering the Jones Act fleet and revitalizing U.S. shipyards.

TRUSTEES ENACT PENSION PARITY ENHANCEMENT

At their November meeting, the Board of Trustees of the M.E.B.A. Pension Plan formally approved the pension parity benefit enhancement described in the December 2023 membership meetings and via Plan Office correspondence regarding Plans Office 2.0. The pension improvement affects members with service both before 2012 and after 2012. It will take effect for those who retire on or after Jan. 1, 2025.

The Trustees – both union and employer – continue to work together to modernize the Plan Office, which is expected to result in substantial administrative cost savings while enhancing the ease and efficiency of member interactions. Enhancements include software upgrades, simplified contributions and improved options for Annual Physicals.

You will receive more information directly from the Plan Office and receive additional details at the upcoming December membership meetings.

PORTS AWARDED MORE THAN HALF A MILLION IN MARAD PIDP GRANTS

The Maritime Administration (MarAd) announced that it has awarded almost \$580 million in Port Infrastructure Development Program (PIDP) awards, funding 31 projects in 15 states and one territory. MarAd's PIDP, received \$2.25 billion from the Bipartisan Infrastructure Law to improve port infrastructure to meet the nation's freight transportation needs. The \$580 million in grants awarded include a cargo terminal replacement in Anchorage, Alaska and a terminal modernization in Oakland, as well as numerous smaller projects at ports around the country. VACATION BENEFITS – 2024 YEAR-END CLOSING

Apply for Vacation and Port Relief Benefits early to avoid the year-end rush.

- **FILING DEADLINE:** The deadline for issuing checks dated in 2024 in the Outports and the Plan Office is Tuesday, December 17, 2024.
- **DIRECT DEPOSIT:** The final Direct Deposit Transfer for 2024 will be made on 12/18/2024 and the funds will be deposited into bank accounts on 12/20/2024.
- Any requests for Port Relief and Vacation checks received after 12/17/24 at 12:00 PM EST will be paid in the order received beginning 1/2/2025.

Any member who requires that his/her check be dated in 2024 must file before this deadline. Remember, Wednesday, December 25, 2024 and Wednesday, January 1, 2025 are holidays and the Outports and the Plan Office will be closed. It is always wise to plan ahead, so you should verify the specific holiday schedule with the Plan Office Representative.

Split Your Vacation Payments between 2024 and 2025

You can submit an Application for Vacation Pay prior to the end of the year and request that the payment of your vacation benefits be split. Two checks will be issued to you, one in 2024 and a second in 2025. The 12/17/2024 deadline applies to split claims also. The vacation benefits paid in

APPLICANTS SEEKING MEMBERSHIP MUST FORWARD DOCS BY END OF NEXT WEEK

Qualified applicants trying to make membership in December must make sure they provide Headquarters with required documentation to ensure their inclusion on the next District Investigating Committee (DIC) report. The DIC meets twice a year to review applicants for membership and will issue a report in late November to be voted upon by members during the regular December membership meetings (December 2-6).

To make membership, an applicant needs the required sailing days or specified years of employment with a particular bargaining unit, must be current with service charges and must complete other necessary requirements which may include an initiation fee and/or letters of recommendation. Applicants should know that they are responsible for providing their local Union hall/Headquarters with the documentation demonstrating their fulfillment of the application requirements. Once they submit the requisite amount of sea time (or documented years of service) to Headquarters and have otherwise fulfilled the needed requirements as stated in the application packet they signed, they may be eligible for membership. Applicants who have fulfilled the necessary requirements should forward their information to Headquarters.

Applicants have been mailed letters from HQ referencing the missing requirements needed for that applicant to make membership. Referenced documents must be submitted to HQ before the DIC finalizes their report at the end of November if the applicant wishes to be considered for membership during this review period. If you have questions about your status, you can contact the Membership Department at membership@mebaunion.org All questions about service charge payments should be directed to the M.E.B.A. Accounting Department at accounting@mebaunion.org. Qualified applicants who fail to make the deadline will have to wait another six months – until the June 2025 report – to make membership.

M.E.B.A. ELECTION: TIME GETTING TIGHT TO GET A DUPLICATE BALLOT

If you are an M.E.B.A. member and did not receive a ballot – or yours has been lost or destroyed – you can request a duplicate ballot in writing. There's not much time so you must act immediately. Our By-Laws state that duplicate ballots "shall be counted unless the original and duplicate ballot mailed to a member are both cast, in which event neither ballot shall be counted." Any written requests for duplicate ballots made to the M.E.B.A. will be referred to the Impartial Administrator: The quickest way to request a duplicate is by emailing TrueBallot at 0212401@trueballot.com Please make sure you include your address to send the duplicate ballot. A reply email is not generated when the request is made. Duplicate ballots are typically delivered by mail within a week of request (dependent on the Post Office. You should contact Marco C. at M.E.B.A. Headquarters - marco@mebaunion.org for any follow-up questions.
