MARITIME LABOR URGES VACCINATIONS

Calling it "a matter of future industry stability and mariner job security," six maritime labor unions issued a strong message for their members to take COVID precautions and get vaccinated. A joint message issued by the leaders of M.E.B.A., AMO, MM&P, SIU, MFOW and SUP pointed out that conflicting policies and protocols at ports, shipyards and elsewhere dictate that ship personnel should protect themselves and others as soon as possible by arming themselves with the COVID-19 vaccine. "Masks, social distancing, hand and respiratory hygiene, cleaning and sanitizing have now become routine," the letter reads, "but the best additional precaution for shipmates and families includes becoming vaccinated."

An arbitrator recently ruled in favor of the American Maritime Association (AMA) upholding a shipping company's right to unilaterally impose vaccine mandates. AMA is a multi-employer bargaining unit made up of Crowley Maritime, 'Horizon Lines' (Matson Navigation), Intrepid Personnel, Maersk Line Ltd., North Star Shipping OSG Ship Management (including Alaska Tanker Company), Sunrise Operations and Tote Services. In addition, the Equal Employment Opportunity Commission (EEOC) recently updated guidance reiterating that federal law does not prevent a private employer from requiring its employees to be vaccinated. As it is, shipping companies have begun instituting 100% vaccine requirements, including Matson Navigation and Chevron Shipping with more to follow. The M.E.B.A. has been working with such companies to make sure members are properly incentivized to support the effort, while also ensuring that the execution of these mandates don't encroach on specific circumstances of our mariner force.

"We understand the stress and anxiety of working in persistent and intensified danger," the maritime leaders wrote, "and so we support fair and common-sense safety practices ashore and at sea. Your dedication, professionalism and perseverance are recognized, and your efforts are best honored by ensuring your own safety and the safety of others aboard ship by getting vaccinated."

Letter signatories included Presidents Adam Vokac (M.E.B.A.) Paul Doell (AMO), Don Marcus (MM&P), Mike Sacco (SIU), Anthony Poplawski (MFOW) and Dave Connolly (SUP). The letter has been posted on the home page of the M.E.B.A. website (www.mebaunion.org).

AMC'S CAPONITI ACCEPTS OVERDUE HONOR

American Maritime Congress President Jim Caponiti has finally been drummed in as an "Outstanding Friend of Seafarers" – a long-delayed, and well-deserved honor awarded by the Seafarers International House (SIH). The SIH is a charitable organization that provides seafarers and travelers with pastoral care, hospitality, social assistance and advocacy. Their (normally) annual "Setting the Course" event in New York City honors those who fight on behalf of the maritime community and is dedicated to the welfare of seafarers. Last year's event was scrapped due to the pandemic.

Jim has poured over 47 years of his heart and soul into the industry – 37 with the Maritime Administration and the past 10 with the AMC. The AMC is a research and education group comprised of an M.E.B.A. and employer-side Board of Directors. Jim was a driving force behind the development and implementation of the Maritime Security Program and was instrumental in MarAd's sealift efforts through the years including the response following September 11, 2001.

At Wednesday evening's event, Jim was joined by several other SIH honorees including recentlyretired MM&P Secretary-Treasurer Steve Werse and American Roll-on Roll-off Carrier President and CEO Eric Ebeling. ITF Maritime Coordinator Jaqueline Smith was also honored as a 2021 Outstanding Friend of Seafarers and special recognition was extended to Tim Ferrie, President of the Marine Society of the City of NY. PORTS LOOK TO REDUCE GREENHOUSE GAS EMISSIONS

Member ports of the American Association of Port Authorities (AAPA) have committed to address climate change on a national and global scale. Efforts, include plans to reduce greenhouse gas (GHG) emissions, support facility electrification, and increase the use of alternative energy sources, while working cooperatively across the maritime industry to advance world-wide climate change initiatives. The AAPA represents more than 140 seaports. AAPA is taking a leadership role in the fight against climate change, including advocating for the creation of a federal port electrification grant program, becoming a founding member of the Blue Sky Maritime Coalition, and announcing a partnership with PortVision50. Blue Sky and PortVision50 were created to facilitate collaboration toward reducing GHG emissions in North America.

AAPA signed onto a letter stating, "A port industry-specific grant program to reduce emissions and electrify port equipment will help spur the adoption of green energy and equipment at ports and allow for faster installation of electric grid and electric equipment charging infrastructure that will be critical in the effort to create a sustainable maritime transportation industry."

USE M.E.B.A. WEBSITE DUES PAYMENT OPTION TO IRON OUT LWOP/VACATION DUES LAPSES

Some M.E.B.A. bargaining unit members pay dues by automatic Dues Check-Off (DCO). But when DCO members take vacation or (in the case of the Government fleet) Leave without Pay (LWOP), there are lapses in payroll where dues aren't automatically submitted. Those members can iron out the imbalance from a link on the M.E.BA. homepage (www.mebaunion.org). Click the link, select the bargaining unit in the "Check Off, Catch-Up" section and make sure you remain a member in good standing. A "Vacation Pay" option is also available. This is useful for port engineers and Union officials who can make these payments online. Many members and applicants think that paying online is the most efficient and advantageous manner to remain in good standing.

HALLS, OFFICES CLOSED ON MONDAY TO HONOR COLUMBUS, INDIGENOUS PEOPLES

M.E.B.A. halls and offices will be closed on Monday Oct. 11 in observance of Columbus Day and the original Admiral of the Ocean Seas - Christopher Columbus. Christopher Columbus has been described as a visionary who opened up the New World and conversely as a greedy imperialist who engaged in slave trading, genocide and stealing Indian land.
